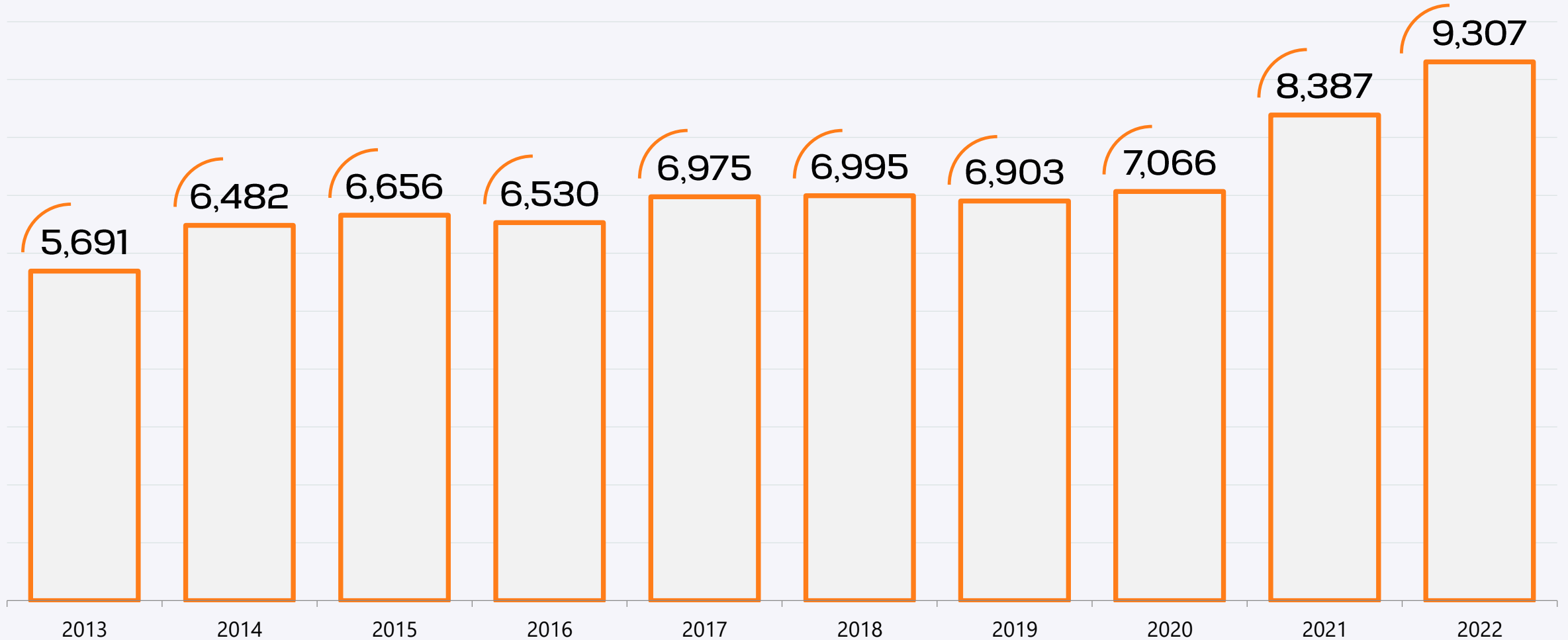

Shmeltzer holdings accumulative turnover and net profit (M NIS)

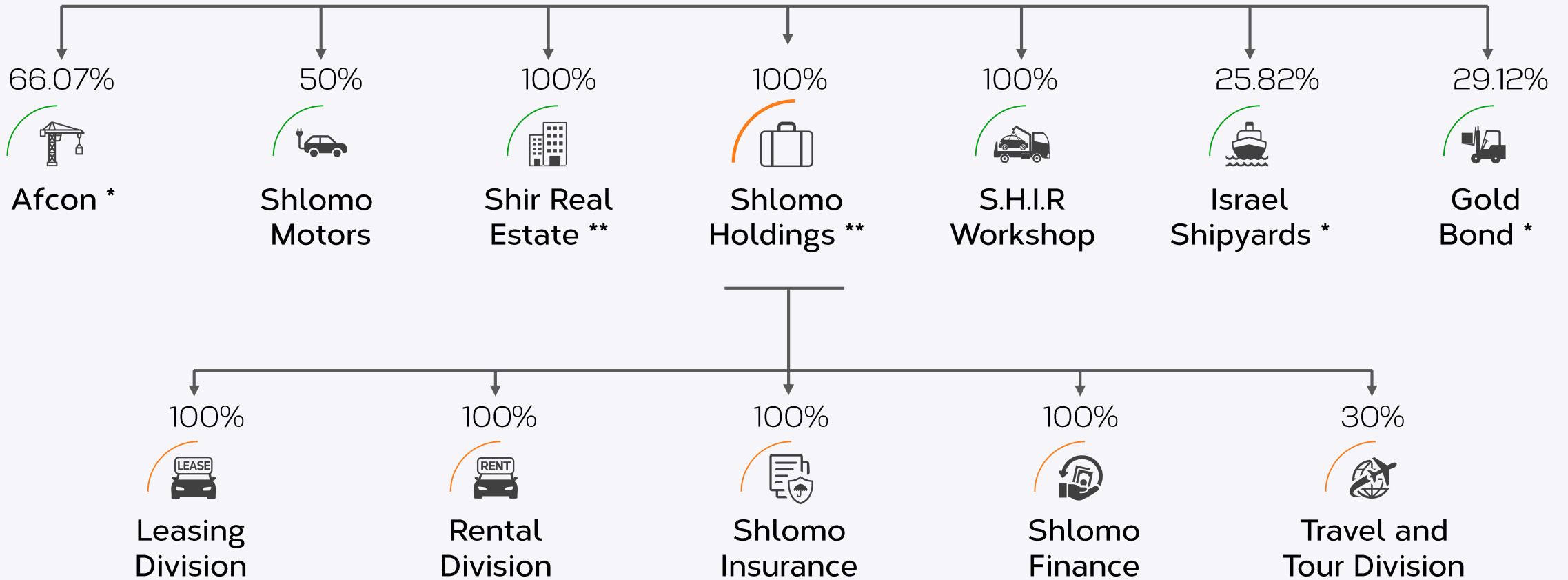


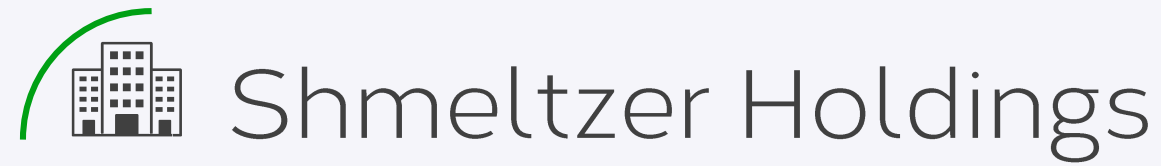


Shmeltzer Holdings
